

## What is a Life Settlement?

A life settlement is the sale of a life insurance policy for a value in excess of the cash surrender value but less than the face value. A successful life settlement transaction means that the seller gets paid cash for the policy and the buyer is responsible to pay all future policy premiums. In return the buyer receives the face value upon the death of the insured.
